- ❖ Beautiful circular Holy Family Chapel offers the holy ground upon which to celebrate your special day, and features:
 - The ambiance of the Southwest
 - Seating for up to 107 guests
 - Variable lighting
 - Heavenly acoustics
 - A sacristy available for wedding celebrant
- ❖ Enclosed courtyard provides a beautiful back-drop for bridal party portraits (landscaping is seasonal)
- ❖ 'Gallery at DeFalco' provides the perfect gathering place for guests before and after the ceremony
- ❖ Large and small meeting rooms are available for your wedding reception. (A/V equipment available)
- ❖ Spacious contemplation chapel is utilized as bride's room
- ❖ Groom's room is spacious and relaxing
- ❖ Our Contemplation Suite makes the perfect honeymoon suite for the happy couple, and includes a champagne basket, complete with champagne flutes and gourmet chocolates.

The DeFalco Package- \$2,200

Includes:

- ❖ Use of Holy Family Chapel, courtyard, and 'Gallery at DeFalco' for engagement or pre-bridal photos for two hours. Time must be scheduled in advance.
- ❖ Use of the chapel and 'Gallery at DeFalco' for two hours the evening before the wedding for the wedding rehearsal
- ❖ The day of the wedding, includes five hour use of the Holy Family Chapel, courtyard, Gallery at DeFalco, one meeting room, bride and groom rooms, contemplation suite for one night (includes champagne basket), and on-site hostess for one hour before, and during your ceremony and reception to assist with facility needs.

The Bishop's Package- \$2,000

Includes:

- ❖ Use of Holy Family Chapel, courtyard, and 'Gallery at DeFalco' for engagement or pre-bridal photos for two hours. Time must be scheduled in advance. After hours use, is an additional \$50/hr.
- ❖ Use of the chapel and 'Galley at DeFalco' for two hours the evening before the wedding for the rehearsal

- ❖ The day of the wedding, includes five hour use of the Holy Family Chapel, courtyard, 'Gallery at DeFalco,' one meeting room, bride and groom rooms.
- ❖ An on-site hostess is present one hour before, and during your ceremony and reception to assist with any facility needs.

Holy Family Chapel Package- \$1,600

Includes:

- ❖ Use of Holy Family Chapel, courtyard, and 'Gallery at DeFalco' for engagement or pre-bridal photos for two hours. Time must be scheduled in advance.
- ❖ Use of the chapel and 'Gallery at DeFalco' for 2 hours the evening before the wedding for the rehearsal
- ❖ The day of the wedding, includes five hour use of the Holy Family Chapel, one meeting room, bride and groom rooms.
- ❖ An on-site hostess is present one hour before, and during your ceremony and reception to assist with any facility needs.

Basic Wedding Package- \$1,400

Includes:

- ❖ Use of Holy Family Chapel and courtyard for engagement or pre-bridal photos for two hours. Time must be scheduled in advance. After hours use, is an additional \$50/hr.
- ❖ Use of the chapel and 'Gallery at DeFalco' for two hours the evening before the wedding for the rehearsal
- ❖ The day of the wedding, includes three hour use of the chapel, and bride and groom rooms.
- ❖ An on-site hostess is present one hour before, and during your ceremony to assist with any facility needs.

Additional Options

- ❖ Pre or Post-wedding lodging for guests- \$60/room/night (single or double occupancy)
- ❖ Table cloth rental- \$10 each
- ❖ Honeymoon suite with champagne basket- \$200
- ❖ Subject to availability, catering is available for rehearsal and/or reception
- ❖ Kitchen rental to approved caterer (must have kitchen manager certification)- \$300/day. Requires advance walk-through with BDRC chef prior to reservation of kitchen.
- ❖ Additional hours of facility use over what is indicated above: \$50/hr until 10:00pm; \$100/hr after 10:00pm

For all wedding packages, a non-refundable deposit in the amount of half of the package selection is required to reserve facility for dates agreed upon by parties.
